Roger is involved in developing the technical data specifications for the pan-European SDI - INSPIRE and led workshops on marine/coastal SDI at the CoastGIS 2011 global conference in Oostende, Belgium, in September 2011; an INSPIRE data specifications workshop for the Flemish government in Belgium also in September; and at the 2011 INSPIRE Conference in Edinburgh, Scotland, in July, he delivered papers on Coastal/Marine SDI and Valuing Geodata, plus contributed to the paper on "SDI: Lessons learned and good practice examples from European experience", co-authored with Bruce McCormack, President of EUROGI.

# Legal and Socioeconomic Committee

The Legal and Socioeconomic Committee explores the legal and economic frameworks within which SDIs are developed in individual nations and across regions, encouraging dialogue on public policy and legal issues and exploring models, approaches, and experiences to enhance cooperation among nations in sharing spatial data and spatial technologies. The committee identifies, acquires, analyzes, and reports on policies and legislation being adopted or considered by national, regional (multinational) or international law bodies that might be relevant to the goals of the GSDI Association or otherwise affect the global SDI development. One of the main projects for 2011-2012 is to develop a GSDI Licensing Framework, for presentation and discussion at the GSDI-13 global conference in Canada, May 2012.

Chair of the Committee is Bastiaan van Loenen, Ph.D., Delft University of Technology, and vice-Chair is Katleen Janssen, Ph.D., of the Interdisciplinary Centre for Law and ICT (ICRI) at the Katholieke Universiteit of Leuven (KUL). Committee vice-Chair, Katleen Janssen led the SPATIALIST Project workshop at ICRI/KUL in March 2011, on "Legal aspects of geographic data and spatial data infrastructures" with L&SE members Paul Uhlir (USA NAS) and Roger Longhorn also in attendance. Chair Bastiaan van Loenen presented "Towards a framework of standard licences for geoinformation", based on work of the Committee to date on this issue. In May, Committee members Katleen Janssen, Paul Uhlir (USA NAS) and Roger Longhorn made presentations at the Legal Aspects of PSI (LAPSI Project) public conference in Milan, Italy, with other members in attendance, including former L&SE Committee Chair Gabor Remetey-Fullop. Several of the European Committee members are also involved in the week-long seminar "Spatial Data Infrastructures (SDI), latest trends and research", to be held in Leuven, Belgium, from 7-11 November 2011.

# Societal Impacts Committee

The Societal Impacts Committee explores the organizational and institutional frameworks within which SDIs are developed locally and in individual nations, across regions and globally. The Committee encourages dialogue and interaction with respect to varying SDI models, approaches, and experiences with the goal to enhance cooperation among nations in sharing spatial content, including spatial data, spatially-enabled services and geoprocessing models. The Committee advises the GSDI Board with regard to funded projects, including grants, cooperative agreements, and contracts, in order to achieve the greatest societal benefit.

The Committee Chair is Carmelle Terborgh, Ph.D., Federal/Global Affairs Team Lead at Esri; vice-Chairs are Brigitta Urban-Mathieux, FGDC USA (vice-Chair, GSDI Small Grants Program), Juna Papajorgji, Univ. of Florida (vice-Chair, Developing Nations Fund) and Jeremy Shen, CIO Ministry of the Interior, Chinese Taipei (vice-Chair, Capacity Building Resources).

The IGS has an ambitious work plan for 2011-2012, involving 33 tasks, with many IGS members already involved in delivering on the many goals and outputs of the plan. One of the many initiatives currently underway is to assess the interaction between SDI and Earth Observation (EO) programmes. Issues to investigate include information policies (balancing 'free' versus 'for a fee' charging and pricing), accessibility, sharing, responsibility, liability and use of information. Concerning SDI service architectures and underpinning metadata catalogue services, is it necessary to implement independent imagery catalogs and how to link associated geographic products to imagery as the data source? Is there a need to formulate new standard services? Other questions include how to avoid duplicating models for implementing SDI and EO programmes – or ensuring compatibility between diverse models?

The GSDI Board of Directors recently passed a motion that allows individuals in low and very low income nations to join the International Geospatial Society (IGS) by providing specific information of value to the global community in lieu of annual cash dues. # THE GEOGRAPHIC INFORMATION KNOWLEDGE NETWORK (GIKN)

The goal of the Geographic Information Knowledge Network (GIKNet) is to enhance communication and freely share knowledge among professionals in the geographic information global community. This is a created and participatory, user maintained commons. Intended users are professionals, agencies, NGO, companies, government practitioners, scholars and students across the globe who have interests in advancing the practice and science of the discipline. GIKN is intended for collective intelligence whereby each community member acts responsibly and makes their own decisions on what, and how much, to contribute.

The GIKNet Community Registry permits individuals, government agencies, NGOs, companies and other



institutions to record and publish details about themselves and submit relevant documents to the Spatial Docs Depot. SDI implementation experiences from all levels of government can be published. #### **RECENT MEMORANDUMS OF UNDERSTANDING**

### GSDI and ISPRS sign MOU on Cooperation

26 August 2011 - During the ISPRS Council Meeting in Melbourne, Australia (22-26 August 2011), a Memorandum of Understanding (MoU) was signed between the GSDI Association and the International Society for Photogrammetry and Remote Sensing (ISPRS). Prof Orhan Altan, ISPRS President, and Abbas Rajabifard, GSDI President, signed for their respective organizations during the ISPRS Council Meeting. The purpose of the MoU is to support better collaboration and to further activities that will provide a framework for a continuing liaison between the two organizations. This will be maintaining achieved by and increasing opportunities for scientific, technical, professional, academic and educational exchanges between committees and members of the organizations and through a continuing program of sharing knowledge expertise to the advantage of both and organizations. Similar MoUs have been signed previously with the International Federation of Surveyors and the International Cartographic Association (see http://www.gsdi.org/associnfo).

# OGC and EuroGeographics Cooperation on European SDI

28 September 2011 - The Open Geospatial Consortium (OGC®) and EuroGeographics signed a memorandum of understanding (MOU) to promote interoperability through open standards to benefit the European geospatial community. The organizations seek to promote compatible, standards-based SDIs from the local to global level, and the OGC is positioned to help EuroGeographics support a broad range of European stakeholders Europe's INSPIRE responding to Directive (http://inspire.jrc.ec.europa.eu/).

Both organizations will work on outreach and communications to raise the awareness, acceptance, and implementation of open standards and related educational programs and best practices. This will include activities such as participation in international webinars; publishing papers on implementations; documenting Return on Investment; and examination and discussion of legal and policy issues associated with the use of spatial information and associated technologies. The two organizations will also work to identify, plan and convene joint workshops, conference sessions and symposia.

In addition, EuroGeographics and the OGC will seek funding and in-kind resources to advance joint OGC testbeds, pilot projects, and interoperability experiments, with a focus on advancing the European Location Framework. (http://sharepsi.eu/papers/eurogeographics-2.pdf)
